

Privacy Policy

This Privacy Policy sets out the obligations and policies of Himalayan Flyers Adventure Sports Club (hereinafter 'Himalayan Flyers', 'the company', 'us', 'we' or 'our') for the uses of personal data collected or received from users (hereinafter "User", "customer") of this website (the "Website"). It describes how we may collect or receive user's personal data, what personal data is being collected, purpose of using personal information that we obtain from customers, how we share and protect these data, and how you can contact us about our privacy practices etc.

HOW WE MAY COLLECT OR RECEIVE PERSONAL DATA FROM USERS

We collect personal data from our website users on a voluntary basis. You may choose to submit your personal data and other information to us through various communication channels provided on the "Contact Us" webpage of the Website, for example, Himalayan Flyers e-mail addresses, telephone numbers or online forms. We may also use cookies or similar technologies that collect certain Website usage information when you access, view and use the Website. A cookie is a data file placed on a computer or mobile device when it is used to visit websites.

WHAT PERSONAL INFORMATION IS BEING COLLECTED ON THE SITE

Personal data collected voluntarily may include first name, last name, address, telephone number, mobile number, fax number, email, and any other information submitted by the customers. Through the cookies we may collect information regarding your website usage, IP address, browser type and operating system. User may disable cookies in his/her browser's settings (e.g., under the "Preferences" or "Internet Options" features of browser). Note, however, that some features of the Website may not function properly if you disable the use of cookies. We encourage you, however, to provide no more personal data relating to you than is necessary in order for us to provide an appropriate response to your inquiries or comments.

PURPOSE OF USING PERSONAL INFORMATION THAT WE OBTAIN FROM CUSTOMERS

The personal data collected will be used only for the purposes we specified at the relevant web page at the time when we invite you to provide your personal data for promotion of our products and services, and for other purposes as may be agreed between you and us or required by law from time to time:

We use your personal data:

- To offers and promotions of our products and services
- To address your comments or inquiries,
- To improve the Website, including to enhance user experience,
- For processing transactions
- For diagnosing problems with our servers,
- For daily operation of our services,
- For customer complaints and enquiries' handling,
- For sending periodic correspondence and administering marketing initiatives

- To make disclosure as required by law,
- And for matters directly related thereto.

If you choose not to provide your personal data, we may not be able to provide the above services.

- **DISCLOSURE OF YOUR INFORMATION TO THIRD PARTY**

Personal data of customers will be kept confidential, we will not sell customer's personal data to any other third party, but we may provide such information to:

- **Associated companies and partners**

We may share your information if required with our associated companies (companies that control, are controlled by, or are under common control with, our Parent Company) as well as select partners on need to know basis. These entities may use your information to make predictions about your interests and may provide you with special offers, promotions, advertisements, and other materials.

- **Legal & Compliance Disclosures**

We may also disclose your Personal Information to Government authorities or other third parties, if required by law or reasonably necessary to protect the rights, property and safety of others or ourselves.

- **DATA SECURITY**

Our company will maintain your personal data securely in our system. Only authorised staff, who has been properly trained, will be permitted to access to such personal data. We take reasonable steps to ensure that the personal information we collect about you remains secure. But unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure and while we strive to protect your personal information, we cannot guarantee or warrant its complete security.
